The ALCAR Group is committed to making a positive contribution to the environment by implementing sustainable practices. The ALCAR Green Deal is our strategic framework aimed at assuming ecological responsibility and making our business processes, products, and services more environmentally friendly. This Green Deal encompasses several key areas: production, supply chain, products, and social engagement.

We are committed in our actions and conduct to the responsible use of resources, the environment, and the interests of our employees, customers, neighbours, suppliers, and society. Adhering to our binding obligations is a given for us.

Our goal is to minimize negative impacts on people and the environment and to avoid waste. We achieve this through:

- sustainable investments,
- clean and energy-efficient processes,
- ongoing monitoring, and
- continuous improvements.

In 2024, we were able to increase the share of electricity consumption from renewable sources to 53 percent (compared to 45 percent in the base year 2023). By 2030, we have set ourselves the goal of continuously increasing this share to 65 percent in order to further reduce CO₂ emissions from fossil fuels.

To promote outstanding environmental performance and integrate it into all processing processes, we adhere to the following principles:

1. **Production Practices:** ALCAR focuses on the development, improvement, and application of environmentally friendly production methods that are not only efficient but also eco-friendly. This includes minimizing waste and emissions in our manufacturing processes.
2. **Materials and Recycling:** ALCAR places great emphasis on the development and manufacture of eco-friendly products, focusing on their use and subsequent recycling. We ensure that the wheels produced can be recycled at the end of their lifecycle to reduce environmental impact.
3. **Energy Efficiency:** ALCAR invests in energy-efficient production facilities and processes. Our production sites are designed to optimize energy consumption, thereby reducing the carbon footprint of our manufacturing activities.

4. **Water:** ALCAR is committed to the responsible use of water as a resource and to the protection of water bodies. In our production processes, we ensure the efficient use of water and strive to minimize our environmental impact as much as possible.
5. **Corporate Policy and Regulatory Compliance:** ALCAR adheres to stringent environmental laws and regulations, as well as industry standards in all regions where we operate. 8. **Sustainable Procurement:** ALCAR works closely with its suppliers to achieve sustainability goals. We prefer suppliers who adhere to high environmental standards and actively work to reduce their ecological footprint.
